## Visit Brief



The meeting with the ONGC Team was conducted in a friendly atmosphere, and key highlights include:

- Mr. Jadav elaborated on AEECPL's unwavering commitment to ONGC regarding the deployment of Installation Safety Officers. He introduced the Project Manager from our corporate office and Project Coordinators at ONGC's Delhi and Mumbai offices.
- Mr. Jadav provided an overview of our organization and the comprehensive technical and administrative support available to the deployed Safety Officers. Regular communication channels with the safety officers were emphasized.
- The ONGC Team allocated specific workplace areas to individual Safety Officers who were deployed.
- ONGC's HSE Head expressed the requirement for each Safety Officer to submit a daily paper report, to be signed by their senior ONGC officer.
- A copy of the daily report, duly signed by the ONGC officer, is designated as a document to accompany the monthly invoice.
- Reporting formats, such as weekly reports, monthly reports, and Hazard reporting, prepared by AEECPL, were presented, and explained to the HSE Team. These reports are to be completed in soft copy and submitted to ONGC's respective offices, as ONGC will not provide a system for submitting reports in soft copy.
