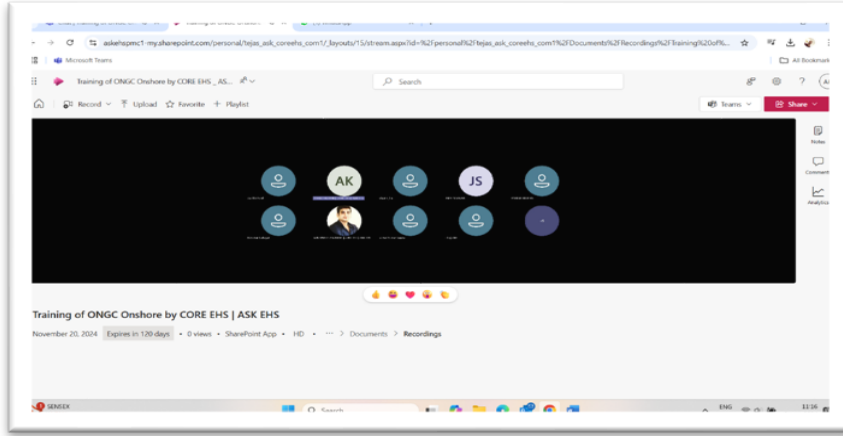
Agenda of the meeting
