#### 4. Identification and Discussion of Safety Gaps:

- The team conducted a thorough review of the current safety processes, highlighting areas of concern and safety gaps.
- Constructive guidance and suggestions were provided to address these gaps effectively, with recommendations to improve safety compliance and operational performance.

#### 5. One-on-One Performance Assessment Discussions:

- Individual sessions were held with each safety officer to assess their performance, identify challenges, and offer tailored technical support.
- Additionally, discussions were held regarding HR-related support, ensuring the safety officers have the necessary resources and guidance to improve their professional development.
